

The State of Illinois requires all incoming 9th grade students to have a physical exam within one year of entering high school and all immunizations need to be up to date. You will find the appropriate forms on the Saint Ignatius website [Forms and Documents](#) page. For your convenience, links to each of the specific forms are posted below.

Your student will not be allowed to participate in Freshman Orientation unless all required forms are on file in the Deans' Office by July 1, 2018.

REQUIRED FORMS:

Illinois Child Health Examination Form: This must be a recent physical within one year of August, 2017 and should include a complete immunization record. **A parent/guardian must complete and sign the health history portion.**

** If your student is going to participate in a sport, the 9th grade physical satisfies that requirement for the freshman year. A "sport's physical" does not satisfy the 9th grade physical requirement.

Immunization Requirements:

- The front of the physical form must have the immunization history filled in and signed by your health care provider.
- The proof of immunization requirements for 9th grade are as follows:
 - Infant/child DTP series-**Students who have not already received Tdap are required to receive one Tdap regardless of the interval since the last vaccine in the series.**
 - Infant/child polio series-the last dose needs to be given ON or AFTER the 4th birthday.
 - Two (2) measles immunizations, the first being given ON or AFTER the 1st birthday.
 - Two (2) mumps and two rubella immunizations, both ON or AFTER the 1st birthday. These immunizations are usually incorporated into an MMR with the measles immunization.
 - Hepatitis B series of three (3) immunizations.
 - Two (2) Varicella immunizations, the first given ON or AFTER the 1st birthday or proof of illness.
 - One (1) dose of meningococcal immunization (MCV4).

Medication Form. All medication, whether **prescribed or over the counter**, must be kept in the Nurse's Office. No Medication is permitted to be carried on the student or taken at any location other than the Nurse's Office with the exception of prescribed inhalers, EpiPens and insulin. If your student will require medication during the school day, a medication form **MUST** be completed by both the PARENT and the PHYSICIAN in order for medication to be given.

Acetaminophen, Ibuprofen and cough drops are stocked in the Nurse's Office. It can only be given to a student with a properly completed medication form on file.

*This form must be updated annually.

If your student takes medication for allergies, asthma or uses an EpiPen, the following forms must also be on file:
